### Author instructions for paper preparation

*Authors are required to follow instructions for preparing their abstract as laid out below. If the document is not following the instructions it will be returned to authors. The final copy of the abstracts WILL NOT be corrected for spelling and English construction so please ensure your document is correctly written. The Editor and Organising Committee reserve the right to reject abstracts that do not substantially meet the instructions below or where the spelling/grammar/English construction make the document not understandable.*

#### General points

1. The abstract must be supplied as a Microsoft Word file and has to be built from the template supplied at [http://www.ecpa2013.udl.cat/papers\\_posters.html](http://www.ecpa2013.udl.cat/papers_posters.html).
2. The document must be only 1 page.
3. Authors who are not native English speakers are strongly advised to have their abstracts checked/corrected by a native English speaker before submission.
4. There is no flexibility on the date for documents to be submitted to the Organising Committee. Authors must therefore keep to the deadlines indicated to them.
5. No figures, tables or reference lists are to be included in poster abstracts. They should be included in the poster image. A CD with the Book of poster abstracts will be provided with all figures in colour.
6. Equations should be written within the text without numeration.

#### Format & structure

Font: 10 pt Times New Roman (except for the title)

Line spacing: single with no extra space between paragraphs

No line or page numbers. No footers. Do not include abstract ID number

Margins: 20mm all sides.

Paragraphs should be fully justified.



The structure of the abstract must be:

- Title –Times New Roman 12 pt, bold, left adjusted, sentence case
- Authors – surname and initial only (no first names), regular, left adjusted, sentence case
- Institutions and Addresses of authors – italics, left adjusted, sentence case
- Email address of corresponding author - regular, left adjusted, sentence case
- Abstract – between 3,000 and 4,000 characters including spaces
- Keywords - 5 maximum (do not include ‘precision agriculture’ or similar)
